# YEAR in highlights

October 1, 2013-September 30, 2014

#### SUMMER CAMP

Exciting new programs were offered at camp this summer. Girls had the opportunity to ride a wave in Surf Camp at Narragansett Beach, hit a bulls eye in the Catch Fire archery program and test their ability and zip-line through the trees of Camp Hoffman on the challenge course.



#### **BOARD CHAIR**

The 2013 annual meeting brought the tenure of Board of Directors Chair, Kathy L. Gann, PhD. to a close and welcomed Lisa M. DeCubellis as her successor. Dr. Gann was an essential asset to the GSSNE Board having served since 2003; she was first elected as Chair of the Board in 2008.

### **CAPITAL CAMPAIGN BREAKFAST**

A breakfast was held in August to promote the Capital Campaign and Girl Leadership Experience Center. Miriam Dash, Gold Award recipient, alumnae and lifetime member, spoke of her involvement as a Girl Scout and how the organization has shaped her future.

### LINGER

In August some young at heart Girl Scouts attended "Linger". This program was geared towards adult members who were up for an overnight at Camp Hoffman. The ladies enjoyed all that Hoffman has to offer. They cherished their time reconnecting with fellow Girl Scouts by reminiscing and enjoying what makes scouting and camp so special.



#### FALL PRODUCT SALE

Girls throughout the council participated in the 2013 fall product sale. Girls sold 28,533 candy and nut products and 5,200 magazine subscriptions. Troops earned over \$41,000 in proceeds to help fund their various activities and projects. They also donated 1,123 candy and nut products and 564 magazine subscriptions to the military as a part of this program.

#### JULIETTE LOW SOCIETY LUNCHEON

On November 21st, friends, alumnae and donors gathered at beautiful Camp Hoffman for the Juliette Low Society Luncheon. Guests enjoyed a gorgeous fall afternoon and CEO Neil M. Stamps shared our exciting plans for the new Girl Leadership Experience Center. Everyone also had the great pleasure to hear from Harley Mitchell, a 2011 Gold Award Recipient, about what Girl Scouting has meant to her.

#### COOKIES

In spite of the snowy weather, girls sold an amazing 61,719 packages of cookies in the 2014 Girl Scout Cookie Sale Program, resulting in over \$387,000 in proceeds and over \$50,000 given back to girls for camp credits. The sale kicked off at the Dunkin Donuts Center on January 5th with lots of fun

The Matty Fund was the beneficiary of the Cookie Sale Community Service Project and troops collectively donated \$5,978.00 to the fund, which improves the lives of children and families living with epilepsy.

### DOVE

GSSNE was the proud recipient of an \$18,000 grant through Dove and the World Associate of Girl Guides and Girl Scouts (WAGGGS) program Free Being Me. This worldwide badge



focused on helping girls better understand global definitions of beauty by defining beauty for themselves and boosting their self-confidence. The grant allowed GSSNE to offer

various self-esteem programs which were offered within the Girl Leadership Experience Center, amongst urban troops and during summer camp, along with the annual Cookie Kick-off.

#### **BIKE TRIP**

Eight girls and three adults took in the sights of Newport during the May Bike Trip, over 18 miles of sights to be exact. The trip included checking out Fort Adams, the Cliff Walk, Salve Regina University, a tour of the Elms, Gooseberry Beach, and of course shopping along Thames Street. The group even witnessed



a remote controlled sailboat regatta off of the point by Fort Adams. This was a great way to take in all that our beautiful state has to offer and get in some exercise to boot.

### **HIGHER AWARDS**

Twenty-four Girl Scout Gold Award recipients were honored on May 31st at a luncheon and ceremony at Rhodes on the Pawtuxet in Cranston, RI. The Young Women of Distinction scholarship honorees who created Gold Award projects which stood out in the areas of creativity, impact and sustainability

### IN HER SHOES




